Chris Shurlock who was in attendance was invited to address the Parish Council. Chris Shurlock gave a brief overview of the MG club and the proposal being put forward.

The following was noted:

- Proposals for a Summer Display of MG cars in the village as a village attraction,
- Chris Shurlock is the Regional Secretary, Eastern England and lives in the village,
- The proposal is to use the playing field to display the cars.
- Suggested dates put forward were 24th May or 21st June.

The Parish Council discussed this proposal in detail and asked Chris Shurlock various questions.

• To consider request from committee to add additional games room

Kevin Sharp gave a brief overview of the proposals and provide a rough sketch of the proposed plans.

• **Children’s Play Area Hedge**

Noted an email of concern has been received from a resident over planting of laurel hedging. The Chairman confirmed advice has been sought from the Royal Horticultural Society. The RHS state serious poisoning is very uncommon in the UK. Some garden plants present a hazard, but the risk of severe poisoning, skin reaction or allergy is generally low. Given this information the Parish Council made the decision to leave the laurel hedging in place at this time. The Clerk was asked to write to the resident information them of the decision taken. **Action: Clerk.**

• **Hedge, School Hall - Update -**

NOTED this has now been cut back. Members raised they did not feel it had been cut back satisfactorily. The Clerk was asked to contact Cambridgeshire County Council to ask them to inspect the hedge to see if they feel works carried out are suitable. **Action: Clerk**
